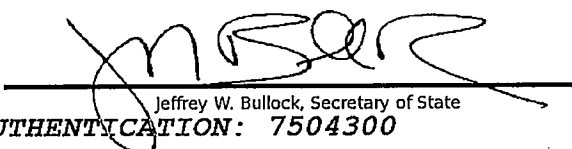

CERTIFICATE OF INCORPORATION OF**

**MULESOURCE, INC.**  
a Delaware corporation

MuleSource, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**Corporation**"), DOES HEREBY CERTIFY THAT:

**FIRST:** The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on April 12, 2006 under the name Azechi, Inc.

**SECOND:** That the Board of Directors of this Corporation, acting in accordance with Section 242 of the General Corporation Law of the State of Delaware, adopted resolutions setting forth the proposed amendment of the Second Amended and Restated Certificate of Incorporation of this Corporation, declaring said amendment to be advisable, and authorizing the appropriate officers of this Corporation to solicit the written consent of the stockholders of this Corporation upon the consideration thereof.

**THIRD:** That thereafter, pursuant to a resolution of the Company's Board of Directors, the written consent of the stockholders of this Corporation was duly called for in accordance with Section 228(a) of the General Corporation Law of the State of Delaware, and the holders of the requisite number of shares as required by statute consented to the adoption of said amendment.

**FOURTH:** That Article I of the Second Amended and Restated Certificate of Incorporation of this Corporation is amended to read in its entirety as follows:

**"ARTICLE I**


The name of the corporation is MuleSoft, Inc."

I hereby declare and certify under penalty of perjury under the laws of the State of Delaware that the facts set forth in the foregoing certificate are true and correct of my own knowledge and that this certificate is my act and deed.
