

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all Assignor's right, title, and interest in and to the Mark, the U.S. Registration, and the CTM Registration, together with the goodwill of the business symbolized by the Mark, the U.S. Registration, and the CTM Registration, and all rights to damages and profits, due or accrued, arising out of past infringements of said Mark, the U.S. Registration, and the CTM Registration, and the right to sue for and recover the same.


