**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of February 13, 2015 (“Effective Date”), by **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company (“WFCE”), in its capacity as agent for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, “Grantee”), in favor of **SHOP HOLDING CORPORATION**, a Delaware corporation (“Parent”), **CONNEXITY, INC.**, a California corporation f/k/a Shopzilla, Inc. (“Borrower”), **ZAPPLI, INC.**, a Delaware corporation (“Zappli”), and **CONNEXITY, INC.**, a Delaware corporation (“Connexity”); Parent, Borrower, Zappli, and Connexity, each a “Grantor” and collectively, the “Grantors”).

**WHEREAS**, reference is made to that certain Credit Agreement, dated as of June 1, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Grantee, Parent, and Borrower;

**WHEREAS**, pursuant to the terms and conditions of (1) that certain Trademark Security Agreement, dated as of June 1, 2011, by and among certain Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on June 2, 2011 at Reel 004552, Frame 0940, (2) that certain Amendment Number One to Trademark Security Agreement, dated as of September 30, 2012, by and among certain Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on October 25, 2012 at Reel 004888, Frame 0945, (3) that certain Amendment Number Two to Trademark Security Agreement, dated as of March 15, 2013, by and among certain Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on March 15, 2013 at Reel 004984, Frame 0091, and (4) that certain Amendment Number Three to Trademark Security Agreement, dated as of February 26, 2014, by and among Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on April 8, 2014 at Reel 005255, Frame 0455 (the documents set forth in items (1) through (4) above, as amended, restated, supplemented, or otherwise modified and in effect from time to time, collectively the “Trademark Security Agreement”), the Grantors granted to Grantee a security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

**WHEREAS**, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.


