THIRD: The name of the surviving corporation is Seamless Medical Systems Inc.

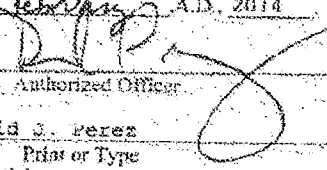
FOURTH: The merger is to become effective on Friday
