TERMINATION OF SECURITY INTEREST IN
TRADEMARKS AND RE-ASSIGNMENT OF INTERESTS

WITNESSETH:

WHEREAS, INTERPACE DIAGNOSTICS, LLC, GROUP DCA, LLC, JS GENETICS, INC. and PDI, INC. NOW, THEREFORE, for valuable consideration, the Bank hereby agrees as follows:



The U.S. Patent and Trademark Office is hereby authorized and requested to discharge the Security Agreement of record as to each of the Released Marks.




