**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of February 28, 2014 (this "Release"), is made by KeyBank National Association, as administrative agent (in such capacity, the "Agent"), in favor of True.Home Heating|Cooling, Inc. (f/k/a Williams Comfort Air, Inc.), an Indiana corporation ("True Home"), as follows:

WITNESSETH

WHEREAS, True Home, Defender Security Company, an Indiana corporation ("Defender"), the Agent and the other parties thereto entered into that certain Credit Agreement on December 13, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, True Home granted the Agent a security interest in certain collateral pledged by True Home pursuant to the Collateral Assignment of Trademarks, dated December 13, 2012, which was recorded with the U.S. Patent and Trademark Office on December 17, 2012 at Reel/Frame No. 4920/0496 as further described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of February 28, 2015, True Home and WCA Group, LLC ("WCA"), True Home sold, assigned, transferred and conveyed, among other assets, the Trademark Collateral to WCA (the "HVAC Disposition"); and

WHEREAS, in connection with the HVAC Disposition, Defender has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at Defender's sole cost and expense hereby terminates, cancels and releases any security interest of the Agent in the Trademark Collateral and any all rights, title and interests of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.
