**TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT**

This Trademark and Domain Name Assignment Agreement (hereinafter referred to as "Assignment") is made by and between GLUCKSTEINHOME, INC., a Canadian corporation with a business address at 234 Davenport Road, Toronto, Ontario M5R 1J8, Canada (the "Assignor"), and BRIAN STEVEN GLUCKSTEIN, a Canadian resident with an address at 234 Davenport Road, Toronto, Ontario M5R 1J8, Canada (the "Assignee") (collectively, the Assignor and the Assignee are referred to as the "Parties").

WHEREAS, Assignor is the owner of the trademark GLUCKSTEINHOME and the goodwill of the business symbolized thereby and associated therewith (referred to as the "Mark");

WHEREAS, Assignor is the owner of U.S. Registration No. 4,294,114 and U.S. Serial No. 85/157,773 for the mark GLUCKSTEINHOME (the "Registration and Application");

WHEREAS, Assignor is the owner of the domain name GLUCKSTEINHOME.COM (the "Domain Name");

WHEREAS, Assignee is desirous of acquiring all Assignor's right, title, and interest in and to the Mark, the Registration and Application, and the Domain Name, and Assignor is desirous of assigning to Assignee all Assignor's right, title, and interest in and to the Mark, the Registration and Application, and the Domain Name;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all Assignor's right, title, and interest in and to the Mark, the Registration and Application, and the Domain Name, including common law rights, together with the goodwill of the business symbolized by the Mark, the Registration and Application, and the Domain Name, and all rights to damages and profits, due or accrued, arising out of past infringements of said the Mark, the Registration and Application, and the Domain Name, and the right to sue for and recover the same. Assignor hereby assigns to Assignee the entire business associated with the Mark, the Registration and Application, and the Domain Name being transferred.

Territory. This Assignment shall be worldwide in scope.

Transfer of Domain Name. Within seven (7) business days following execution of this Assignment, Assignor shall effectuate with any registrar the transfer of the Domain Name to Assignee pursuant to the registrar's domain name transfer procedure and shall furnish and execute any additional documents and information as Assignee or the registrar may require in order to effectuate and establish Assignee's ownership of the Domain Name, including without limitation, appropriate transaction identification numbers, security codes, and authorization codes.


Representations and Warranties. Assignor represents and warrants that Assignor does not own any other mark or domain name that incorporates the mark GLUCKSTEIN or GLUCKSTEINHOME or a mark confusingly similar thereto. Assignor's failure to identify a domain name or trademark that incorporates the mark GLUCKSTEIN or GLUCKSTEINHOME shall not abrogate Assignor's affirmative duty to assign the domain name and trademark to Assignee.

Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark and Domain Name Assignment.
