## RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest is made this 27th day of February, 2015, by and between Wells Fargo Bank, National Association, with an address of 100 West Washington Street, 25th Floor, Phoenix, Arizona 85003, as administrative agent ("Releasor") in favor of IO Data Centers, LLC, a Delaware limited liability company with an address of 615 North 48th Street, Phoenix, Arizona 85008 ("Releasee").

### RECITALS

A. Releasee is the owner of certain trademarks, including, without limitation, the trademarks listed on the attached Schedule A (collectively, the "Trademarks"); and

B. Pursuant to the Trademark Security Agreement ("Security Agreement") between Releasor and Releasee dated October 6, 2010, which was recorded with the United States Patent and Trademark Office ("USPTO") on October 7, 2010 at Reel/Frame No. 4292/0501, Releasor was granted a security interest in the Trademarks.

C. Given that the guaranty of the BaseLayer Entities and the Liens created by the Security Documents on the related property transferred in connection with the BaseLayer Spin-Off have been automatically released pursuant to Section 13.9(a) of the Credit Agreement, Releasee has requested that Releasor release all of its right, title, and interest in and to the Trademarks.

### AGREEMENT

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor does hereby release any and all right, title, and interest (including all security interests) it may have in and to the Trademarks (including the applications and registrations therefor and the goodwill associated therewith) pursuant to the Security Agreement, the recordation at Reel/Frame 4292/0501, or otherwise.

Releasor will execute such other documents and instruments, and take other such actions (at the expense of Releasee) as Releasee may reasonably request to evidence this termination and release and the release of any other security interest Releasor may have in and to the Trademarks.
