RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of March 3, 2015, by Wells Fargo Bank, National Association, as successor in interest to Wachovia Bank, National Association, as successor in interest to Lehman Commercial Paper Inc. (in such capacity, “**Administrative Agent**”), for itself and the other lenders (collectively, “**Lenders**”) from time to time parties to the Credit Agreement referred to below, in favor of each of West Corporation, a Delaware corporation (“**West**”), West Asset Management, Inc., a Delaware corporation, and the other entities listed on Schedule 1 (collectively, the “**Grantors**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in such Credit Agreement.

WITNESSETH:

WHEREAS, reference is made to the Amended and Restated Credit Agreement, dated as of October 5, 2010 (as amended, supplemented and/or otherwise modified prior to the date hereof, the “**Credit Agreement**”), by and among West, the Lenders, the Administrative Agent and the other agents and parties thereto, which amends and restates the Credit Agreement, dated as of October 24, 2006, by and among West, the lenders from time to time party thereto, the Administrative Agent and the other parties thereto, as amended, supplemented and/or otherwise modified;

WHEREAS, reference is made to the Intellectual Property Security Agreement, dated as of October 24, 2006 (as amended supplemented and/or otherwise modified prior to the date hereof, the “**IP Security Agreement**”), by and among West, the Administrative Agent and the other parties thereto;

WHEREAS, pursuant to the IP Security Agreement, each of the Grantors, granted security interests to the Administrative Agent for the benefit of the Secured Parties in certain trademark registrations owned by such Grantors, including the trademark registrations set forth on Schedule 2 (the “**Trademark Collateral**”), notice of which was recorded at the United States Patent and Trademark Office at the Reel and Frame numbers set forth on Schedule 2;

WHEREAS, pursuant to the Partial Release Letter, dated as of the date hereof, from the Administrative Agent to the Grantors and certain other parties, the Administrative Agent released any security interest granted by the Grantors in the Trademark Collateral;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby re-pledges to the applicable Grantors the Trademark Collateral and releases any and all security interest it has against the Trademark Collateral, without any representation, warranty, or recourse of any kind.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such right, title or interest in such Trademark Collateral to the applicable Grantor as set forth on Schedule 2, without any representation, warranty, or recourse of any kind.

At the Grantors’ sole cost and expense, the Administrative Agent shall take any and all reasonably required further actions, and provide to the Grantors and their successors, assigns, designees or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments, which are in form and substance satisfactory to Administrative Agent), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed by its duly authorized officer as of the day and year first above written.
