RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated February 27, 2015 by Bank of Montreal, a Canadian chartered bank, with its mailing address at 100 King Street West, 11th Floor, Corporate Finance Division, Toronto, Ontario, Canada M5X 1A1 ("*Secured Party*");

WITNESSETH:

WHEREAS, The Orthotic Group Inc. ("*Debtor*"), with its mailing address at 160 Markland Street, Markham, Ontario, Canada L6C 0C6, and Secured Party were parties to a certain Confirmation of Security Interest in Intellectual Property dated April 1, 2013 between Debtor and Secured Party which was recorded in the United States Patent and Trademark Office ("USPTO") on April 3, 2013 at Reel 4997, Frame 0382, certain security agreements recorded at the USPTO on October 20, 2008 and September 23, 2011 and certain security agreements filed with the Canadian Intellectual Property Office on December 2, 2008, October 13, 2011 and April 11, 2013, pursuant to which Debtor granted to Secured Party a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

Secured Party hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Secured Party, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:

(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
