TRADEMARK ASSIGNMENT

THIS ASSIGNMENT of United States Trademarks is made effective as of the 24 day of February, 2015 by and between Nannini S.p.A., an Italian Società per Azioni; Nannini Firenze S.r.l., an Italian Società a Responsabilità Limitata (Nanini S.p.A. and Nannini Firenze S.r.l. collectively, "Assignors"); and Nannini Group S.r.l., an Italian Società a Responsabilità Limitata located at 17, Via Righi 52100 Arezzo, Italy ("Assignee") (each individually, a "Party" and collectively, the "Parties").

WHEREAS, Nannini S.p.A is the record owner of the NANNINI marks in the U.S., including, but not limited to U.S. Trademark Registrations NANNINI and Design, U.S. Reg. No. 2,931,292, and NANNINI and Design, U.S. Reg. No. 2,152,684 (the "Trademarks");

WHEREAS Nannini S.p.A. assigned all right, title, and interest in the Trademarks to Nannini Firenze S.r.l. in 2011;

WHEREAS Nannini Firenze S.r.l. assigned all right, title and interest in the Trademarks to Assignee in November 2014;

WHEREAS, the undersigned trustee in bankruptcy is the appointed trustee with authority to dispose of all assets of Nannini S.p.A. and Nannini Firenze S.r.l.;

WHEREAS each Party wishes to record the assignment of all right, title, and interest in the Trademarks, including the goodwill of the business associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, Assignors do hereby memorialize the assignment, transfer and conveyance unto the Assignee of all of their respective right, title, and interest in and to the Trademarks together with the good will of the business associated with the use of and symbolized by the Trademarks, as well as all rights of action against third parties for past infringement thereof.

Each Party further covenants and agrees that it has the right and authority to make this assignment and has not assigned the Trademarks to any third party.

Assignors undertakes that upon the request of Assignee or its designees, it and/or its successor in business, shall make all rightful oaths, testify on behalf of Assignee or its designees in matters involving the Trademark and do all other lawful acts necessary to carry out the intent of this Assignment as well as to provide such other material, documents, information and assistance to Assignee or its designee, as may be considered necessary in connection therewith all at the expense of Assignee.


