## DECLARATION OF RELEASE OF SECURITY INTEREST

The following Declaration of Release of Security Interest ("Declaration") is made by Jones Apparel (US) LLC ("Jones Apparel"), current owner of certain trademark registrations, further identified on Schedule A attached hereto (the "Trademarks"), in an effort to clarify and complete the chain of title records for such Trademarks at the U.S. Patent and Trademark Office ("USPTO"). Specifically, Jones Apparel desires to provide notice in the USPTO records that certain security interests previously granted by Palm Beach Company and T-M Ventures, Inc. to Plaid Holdings Corp. and PBC Holdings Incorporated are no longer in effect and have been released. Accordingly, Jones Apparel provides the following declaration.

I, Andrew Hede, hereby declare as follows:

1. I am a Vice President of Jones Apparel, and am duly authorized to give and execute this Declaration on behalf of Jones Apparel.
2. According to USPTO records, on October 16, 1992, Palm Beach Company granted a security interest to Plaid Holdings Corp. and PBC Holdings Incorporated (both identified as Delaware entities) in certain trademarks, including those Trademarks identified on Schedule A attached hereto. According to USPTO records, this security interest was recorded against the Trademarks on October 20, 1992, at Reel/Frame 0899/0615.
3. According to USPTO records, on October 16, 1992, T-M Ventures, Inc. granted a security interest to Plaid Holdings Corp. and PBC Holdings Incorporated (both identified as Delaware entities) in certain trademarks, including those Trademarks identified on Schedule A attached hereto. According to USPTO records, this security interest was recorded against the Trademarks on October 20, 1992, at Reel/Frame 0899/0560.
4. Although Jones Apparel believes to the best of its knowledge that such security interests granted to Plaid Holdings Corp. and PBC Holdings Incorporated are no longer in effect, Jones Apparel is unable to locate, after due diligence, a signatory to sign a confirmatory release because these entities no longer exist.
5. A search of the Delaware Secretary of State online records shows no current entity information for Plaid Holdings Corp. or PBC Holdings Incorporated.

6. A search of the New York Department of State online records shows that Plaid Holdings Corp. changed its name to Plaid Clothing Group Inc., but a search of Delaware Secretary of State online records shows no current entity information for Plaid Clothing Group Inc. either.
7. A search of the New York Department of State online records shows that PBC Holdings Incorporated changed its name to Palm Beach Company, Inc., but such entity was dissolved in 1996.
8. In sum, upon information and believe, the entities to which the above-referenced security interests were granted are no longer existing, and Jones Apparel has been unable to locate a successor in interest to such entities.
9. Accordingly, after due diligence on this matter, Jones Apparel is unable to locate any existing entity that is able to sign a confirmatory release of the security interest, and therefore offers this Declaration as confirmation that to the best of its knowledge, the above-referenced security interests are no longer in effect and should be considered released and/or terminated in the USPTO records.
10. I further declare that all statements herein of my own knowledge are true and that all statements made on information and belief are believed to be true, and further that these statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code.
