RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This Release of Security Interests in Intellectual Property is made as of the 27 day of February, 2015 (the "Release Date"), in favor of NORTH AMERICAN RESCUE, LLC, a Delaware limited liability company ("Grantor") by THE GOVERNOR AND COMPANY OF THE BANK OF IRELAND, as collateral agent (in such capacity "Secured Party").

WHEREAS, an Intellectual Property Security Agreement, dated January 2, 2014, by the Grantor in favor of Secured Party was recorded on January 3, 2014 (i) by the Trademark Assignment Division of the U.S. Patent and Trademark Office, at Reel/Frame 005186/0468, and (ii) by the Patent Assignment Division of the U.S. Patent and Trademark Office, at Reel/Frame 031911/0980 (as amended pursuant to the Supplemental Intellectual Property Security Agreement referenced below, the "Security Agreement").

WHEREAS, a Supplemental Intellectual Property Security Agreement between the Grantor and Secured Party was entered into to amend the Security Agreement, and such Supplemental Intellectual Property Security Agreement was recorded on February 7, 2014 by the Patent Assignment Division of the U.S. Patent and Trademark Office, at Reel/Frame 032176/0751.

WHEREAS, the Grantor has made payment to satisfy the obligations owed to the Secured Party by the Grantor under the above recorded Security Agreement, and the Secured Party has agreed to terminate, release and discharge its security interest in all of the Intellectual Property Collateral (as such term is defined in the Security Agreement), including, without limitation, the Patents listed on Schedule A and the Trademarks listed on Schedule B.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Secured Party hereby agree as follows:

All of Secured Party's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created pursuant to the Security Agreement (collectively, the "Security Interests") shall be automatically terminated, released and discharged, and the Secured Party shall sign any additional termination documents reasonably requested in writing by Grantor at Grantor's cost and expense, including filings with the U.S. Patent and Trademark Office against the Patents listed on Schedule A and the Trademarks listed on Schedule B hereto, as shall be necessary to effect the termination, release and discharge of all of the Security Interests, each at Grantor's cost and expense.

If and to the extent that Secured Party has acquired any right, title or interest in or to any of the Intellectual Property Collateral (as that term is defined in the Security Agreement), it hereby assigns and transfers such rights, title or interest to Grantor, along with any goodwill in the Trademarks that the Secured Party may have acquired.

This Release may be executed in any number of counterparts, but all of such counterparts shall together constitute one and the same instrument. This Release shall be governed and construed in accordance with the laws of the State of New York, without regard to the principles thereof relating to conflict of laws.


