**TRADEMARK AND DOMAIN NAME CONTRIBUTION AGREEMENT**

This TRADEMARK AND DOMAIN NAME CONTRIBUTION AGREEMENT (this "Agreement") is effective as of February 1, 2015 (the "Effective Date"), and is made by and between TechCrunch, Inc., a Delaware corporation (the "Parent"), and CrunchBase, Inc., a Delaware corporation (the "Subsidiary").

**RECITALS**

WHEREAS, Parent is the sole stockholder of the Subsidiary;

WHEREAS, Parent operates, among other things, the CrunchBase business (the "CrunchBase Business");

WHEREAS, the Parent is the owner of certain trademarks ("Trademarks") and domain names ("Domains") set forth in Exhibit A and Exhibit B, respectively and attached hereto, necessary for the operation of the CrunchBase Business.

WHEREAS, the Parent desires to transfer and contribute to the Subsidiary all of its right, title and interest in and to all of the Trademarks and Domains, and any trademark or service mark rights therein, the goodwill and all common law rights related thereto and the right to bring claims of infringement and misappropriation of the foregoing against third parties and (collectively, the "Contributed Assets"), and the Subsidiary desires to receive the Contributed Assets;

WHEREAS, the parties intend that the contribution of the Contributed Assets qualify as a tax-free contribution;

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

**Section 1. Contribution.** Effective as of the Effective Date, the Parent hereby assigns, conveys, transfers and delivers to the Subsidiary, all of its right, title and interest in and to the Contributed Assets. Parent hereby waives any future beneficial right of Parent or any subsidiary of Parent other than Subsidiary to use the Contributed Assets.

**Section 2. Acceptance and Acknowledgment.** As of the Effective Date, the Subsidiary hereby accepts and acknowledges all of the right, title and interest in the Contributed Assets.

**Section 3. Tax Free Contribution.** The contribution of the Contributed Assets by Parent to Subsidiary is intended to qualify as a tax-free contribution. The parties agree to take all such actions as are necessary and appropriate to obtain such result.

**Section 4. Non-US Domains.** To the extent that local laws require any of the existing Domains to be held by a legal entity in a specific jurisdiction, the parties hereby agree that Parent endeavors to hold, or require an affiliate to hold, such domain in trust on behalf of Subsidiary until otherwise instructed by Subsidiary.

**Section 5. Further Assurances.** Each party hereto shall execute, deliver, file and record, or cause to be executed, delivered, filed or recorded, such further agreements, instruments and other documents, including but not limited to a trademark coexistence agreement, and take or cause to be taken, such further actions, as the other party hereto may reasonably request as being necessary or advisable to effect or evidence the transactions contemplated by this Agreement.

**Section 6. General Provisions:**

(a) **Entire Agreement.** This Agreement constitutes the entire agreement between the parties pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

(b) **Amendments.** No supplement, modification or amendment of this Agreement shall be binding unless executed in writing by both parties hereto. The parties agree that for purposes of clarity and accuracy, the parties will use commercially reasonable efforts to modify Exhibits A-C within thirty (30) days of the Effective Date to the extent necessary to refine the assets that are exclusively related to the CrunchBase Business. To the extent that such modification is necessary, the parties agree that the transfer of all such assets and liabilities shall be considered to be made as of the Effective Date. In addition, the parties recognize and agree that nothing in this Agreement precludes the parties from modifying such exhibits after the thirty (30) day period as necessary to ensure that the exhibits are current and accurately reflect all and only such assets that are exclusively related to the CrunchBase Business consistent with the parties intent as reflected herein

(c) **Waivers.** No waiver or change in this Agreement will be binding unless executed in writing by the party making the waiver or affected by the change.

(d) **Successors and Assigns.** The provisions of this Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

(e) **Headings.** In this Agreement, headings of sections are for convenience of reference only and have no substantive effect.

(f) **Applicable Law.** This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to its conflict of laws doctrines.

(g) **Counterparts.** This Agreement may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.

(h) **Severability.** If any one or more provisions contained in this Agreement shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision of this Agreement, but this Agreement shall be construed as if such invalid, illegal or unenforceable provision had never been contained herein.
