NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the Agreement, Assignor hereby assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to said Marks, together with the Intellectual Property and the goodwill of the business connected with the use of the Intellectual Property and the use of and symbolized by the Marks, and all claims, if any, which may have arisen there under prior to the date of this instrument.

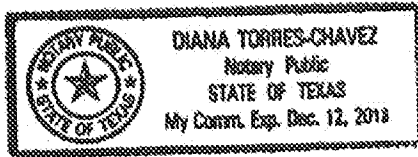
