## **TRADEMARK SECURITY RELEASE AGREEMENT**

This TRADEMARK SECURITY RELEASE AGREEMENT (“**Security Release**”) is effective as of March 9, 2015, executed and delivered by CoBank, ACB, as Administrative Agent, having a place of business at 5500 South Quebec Street, Englewood, Colorado 80111 (the “**Administrative Agent**”), in favor of Long Lines, LLC (the “**Owner**”).

WHEREAS, the Owner and the Administrative Agent entered into a Grant of Security Interest in Trademarks (the “**TM Security Agreement**”), whereby the Owner granted the Administrative Agent a security interest in certain trademarks;

WHEREAS, the Administrative Agent now agrees to release the security interests it may have with respect to the trademarks listed on Schedule A (the “**Released Trademarks**”), on the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the above, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

Section 1. Release of Security in Released Trademarks. The Administrative Agent hereby does release, sell, assign and transfer to Owner without recourse, representation or warranty of any kind (except as provided in Section 2 hereof) the Administrative Agent's absolute, unconditional, continuing first priority security interest in and to Owner's entire right, title, and interest in and to the Released Trademarks, including all rights the Administrative Agent may have with respect to:

- (a) the Released Trademarks, including all goodwill associated with and symbolized by the Released Trademarks; and
- (b) any and all claims and causes of action for past, present, or future infringement of the Released Trademarks, including the right to sue for and collect damages for infringement of the Released Trademarks; and
- (c) any and all rights the Administrative Agent may have to licenses or rights granted under the Released Trademarks, and all license fees and royalties arising from such licenses or rights, to the extent permitted by such licenses or rights; and
- (d) any and all amendments, renewals, reissuances and replacements of the Released Trademarks.

Section 2. Binding Effects; Benefits. This Security Release shall be binding upon the Administrative Agent and its successors and assigns, and shall inure to the benefit of the Owner and its successors and assigns.


Section 3. Section Headings. The Section Headings herein are for convenience of reference only, and shall not affect in any way the interpretation of any of the provisions hereof.
