RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made and entered into as of March 9, 2015 (“Effective Date”) by and between Exar Corporation, a Delaware corporation, having an office at 48720 Kato Road, Fremont, California 94538, Cadeca Microcircuits, LLC a Colorado limited liability company, having an office at 1215 S. Grant Ave., Loveland, Colorado 80537, Stretch, Inc., a Delaware corporation, having an office at 48720 Kato Road, Fremont, California 94538 (collectively the “Grantors”) and Stifel Financial Corp., a Delaware corporation, having an office at 501 North Broadway, St. Louis, Missouri 63102, as Administrative Agent for the Lenders (in such capacity, together with its successors and assigns in such capacity the “Agent”).

WHEREAS, the Agent for the benefit of each Secured Party is the holder of a continuing security interest in all of Grantors’ right, title and interest in, to and under all Collateral, including the trademark registrations and trademark applications listed on Schedule A pursuant to that certain Trademark Security Agreement, dated May 27, 2014, which is recorded with the United States Patent and Trademark Office at Reel 5291 Frame 0154, (the “Security Agreement”); and

WHEREAS, Grantors desire to record this instrument to evidence termination of the security interest.

NOW, THEREFORE, the Grantors and Agent agree as follows:

1. Unless otherwise defined herein, all capitalized terms defined in the Security Agreement and used herein shall have the meaning given to them in the Security Agreement.

2. The Agent hereby expressly releases and discharges fully, the security interest in and lien on the Collateral (including, without limitation, the trademarks identified in Schedule A hereto) as granted pursuant to the Security Agreement and Agent reconveys, transfers, and assigns to Grantors, as applicable, without recourse, representation or warranty of any kind, any rights it may have in the Collateral pursuant to or in connection with the Security Agreement and any right, title or interest of Agent shall hereby cease and become void.


