Pursuant to Section 252(c), of the
General Corporation Law

DELAWARE KSHE, INC., a corporation formed under the laws of the State of Delaware, desiring to merge into itself KSHE, INC. pursuant to the provisions of Section 252(c), of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY as follows:

FIRST: That the names and states of incorporation of each constituent corporation are:

<u>NAME</u>	<u>STATE OF INCORPORATION</u>
KSHE, INC.	Missouri
DELAWARE KSHE, INC.	Delaware

SECOND: That a Plan and Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each constituent corporation in accordance with Section 252(c) of the General Corporation Law.

THIRD: That the name of the surviving corporation is to be KSHE, INC. (changed from DELAWARE KSHE, INC. pursuant to paragraph FOURTH below).

FOURTH: The Certificate of Incorporation of DELAWARE KSHE, INC., as amended by the Plan and Agreement of Merger, shall be the certificate of the surviving corporation, except that Article 1. of the Certificate of Incorporation is

amended to read as follows:

1. The name of the corporation is
KSHE, INC.

Article 4. of the Certificate of Incorporation is amended to read as follows:

4. The total number of shares of Common Stock which the corporation shall have authority to issue is six hundred twenty-five thousand (625,000) and the par value of each of such shares is Ten Cents (\$0.10) amounting in the aggregate to Sixty-Two Thousand Five Hundred Dollars (\$62,500).

FIFTH: That an executed copy of the Plan and Agreement of Merger is on file at the principal place of business of DELAWARE KSHE, INC., Crestwood, Missouri, and that a copy thereof will be furnished by the surviving corporation, on request and without cost, to any stockholder of any constituent corporation.

SIXTH: That the authorized capital stock of KSHE, INC. (the Missouri corporation) is 625,000 shares of Common Stock, par value \$0.10 per share.

IN WITNESS WHEREOF, DELAWARE KSHE, INC. has caused this Certificate to be executed by its officers thereunto duly authorized this 22nd day of July, 1977.
