TRADEMARK ASSIGNMENT NUNC PRO TUNC

This Trademark Assignment (“Assignment”) is entered into *nunc pro tunc* to be effective as of November 12, 2008 (“Effective Date”), by and among Gary Abel, Bruce Abel, Bobby L. Windham and M. Tate Wood (collectively, the “Assignors”) and Icon Outdoors, LLC, a Maryland limited liability company (“Assignee”) having a principal place of business at 3451 Ellicott Center Drive, Ellicott City, MD 21043.

WHEREAS, Assignors entered into that certain Assignment with Icon Outdoors, Inc., dated November 12, 2008, whereby Assignors assigned to Icon Outdoors, Inc., the entire right, title, right and interest in and to the following trademarks (hereinafter the “Marks”), together with the goodwill of the business connected with and symbolized by the Marks, and the right to sue for past infringement thereon:

WHEREAS, Assignors and Assignee wish to clarify and memorialize the prior understanding of the parties that Assignors assigned to Assignee all right, title and interest in and to the Marks as of the Effective Date

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee agree as follows:

Assignors do hereby sell and assign *nunc pro tunc*, effective as of the Effective Date, to the Assignee, its successors, assigns, nominees, or other legal representatives, the entire right, title, right and interest in and to the Marks in the United States and all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, together with: (1) the goodwill of the business connected with and symbolized by the Marks; (2) all income, royalties or payments due or payable as of the Effective Date or thereafter, including the right to sue third parties for past, present, and future infringement of or improper activities regarding the Marks, with the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action); and (3) all rights at common law in and to the Marks.
