NOW, THEREFORE, in consideration of the payment in the amount of _____ which was paid in accordance with Paragraph 5 of the License Agreement, and, the full receipt, full acceptance, and sufficiency of which is hereby acknowledged by ASSIGNEE, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Property, together with (1) the goodwill of the business relating to Goods/Services for which the Property is used and for which they are registered, (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Property, including without limitation, damages, and payments for past or future infringements and misappropriations of the Property, and (3) all rights to sue for past, present and future infringements or misappropriations of the Property.

ASSIGNOR further covenants that it will execute all reasonably necessary documents, papers, forms and authorizations and take all other actions that may be reasonably necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Property.
