**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of March \_\_\_\_\_ 11, 2015, is made by PRC-BL Funding, LLC and PRC-BL Funding Parallel, LLC, which are limited liability companies organized under the laws of Delaware (together with its successors and assigns in such capacity, "**PRC**"). Terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement, as applicable.

**WHEREAS**, PRC is a party to that certain Security Agreement, dated as of August 31, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**");

**WHEREAS**, in connection with that certain Security Agreement, PRC was granted a security interest in certain assets owned by Brite-Line Technologies, LLC, a Delaware limited liability company, successor-in-interest to Brite-Line Technologies, Inc., a Massachusetts corporation (the "Trademark Owner") including certain intellectual property owned by the Trademark Owner, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, in connection with that Security Agreements, a Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on the date and on the reel and frame set forth on Annex I hereto;


**NOW THEREFORE**, PRC hereby terminates the Security Agreement and Trademark Security Agreement and releases, without representation, recourse or warranty whatsoever, all of their security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreement or Trademark Security Agreement or any other agreement or document delivered in connection therewith, and PRC hereby reassigns any and all such right, title and interest (if any) that the PRC may have in the Intellectual Property Collateral to the Trademark Owner.

PRC agrees to take all further actions, and provide the Trademark Owner, their successors, assigns, or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments, which must be prepared and filed by the Trademark Owner, at the sole cost and expense of the Trademark Owner) reasonably requested by Trademark Owner to more fully and effectively effect the purposes of this Release.

**IN WITNESS WHEREOF**, PRC has executed this Release of Security Interest in Intellectual Property Collateral as of the date first above written.


