RELEASE OF SECURITY INTEREST IN TRADEMARKS

March 10, 2015

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is conveyed as of March 10, 2015 by CORTLAND CAPITAL MARKET SERVICES LLC, in its capacity as administrative agent under the Term Loan Agreement referred to below (in such capacity, the "Administrative Agent"), to the Grantors identified on Schedule I attached hereto (the "Grantors"). Capitalized terms used herein but not defined herein shall have the meanings ascribed to them in the Security Agreement or the Trademark Security Agreement, as applicable, referred to below.

WHEREAS, pursuant to (i) that certain Subordinated Term Loan Agreement, dated as of February 28, 2014 (as amended, modified or supplemented from time to time, the "Term Loan Agreement"), by and among SAGER CREEK VEGETABLE COMPANY (f/k/a Allens, Inc. (f/k/a Sager Creek Acquisition Corp.)), a Delaware corporation (the "Borrower"), HICO HOLDINGS LLC, a Delaware limited liability company ("Parent"), the Subsidiaries of the Borrower from time to time parties thereto as guarantors (each such Subsidiary, together with the Parent, each being a "Guarantor" and collectively, the "Guarantors"), the financial institutions party thereto from time to time as lenders (collectively, "Lenders") and the Administrative Agent and (ii) that certain Pledge and Security Agreement, dated as of February 28, 2014 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Grantors and the Administrative Agent, the Grantors entered into that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of February 28, 2014, with the Administrative Agent, which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 4, 2014 at Reel 5229, Frame 0441; and

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantors granted a security interest to the Administrative Agent in all right, title and interest throughout the world in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademark Collateral identified on Schedule II attached hereto (the "Security Interest").


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby discharges, cancels, terminates and releases the Security Interest granted under the Security Agreement and Trademark Security Agreement.

The Administrative Agent acknowledges that this Release may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any conflict of law principles thereof.
