**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of March 12, 2015, is made by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent (in such capacity, together with its successors and permitted assigns, the "**Agent**") for the Secured Parties. Capitalized terms used and not defined herein shall have the meanings set forth in the Guaranty and Security Agreement referenced below.

**WHEREAS**, each Grantor (other than the Borrower) has agreed, pursuant to a Guaranty and Security Agreement dated as of February 9, 2012 in favor of the Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "**Guaranty and Security Agreement**"), to guarantee the Guaranteed Obligations;

**WHEREAS**, in connection with the Guaranty and Security Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Grantors granted security interests in favor of the Agent, for the benefit of the Secured Parties, in certain Collateral of such Grantors, including, without limitation, the intellectual property listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**");

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto; and

**WHEREAS**, the Grantors have requested a specific release of the security interests granted in favor of the Agent, for the benefit of the Secured Parties, and recorded against the Intellectual Property Collateral.

**NOW THEREFORE**, the Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent or the Secured Parties may have in the Intellectual Property Collateral to the Grantors. The Agent agrees, at the expense of the Grantors, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required to effect the release of the Agent's security interests in the Intellectual Property Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
