**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of March 12, 2015, is made by Wells Fargo Bank, National Association, (together with its successors and assigns in such capacity, "**Secured Party**"). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, as applicable.

**WHEREAS**, Brite-Line Technologies, LLC, a Delaware limited liability company, successor-in-interest to Brite-Line Technologies, Inc., a Massachusetts corporation (the "**Assignor**") and Secured Party are parties to that certain Credit and Security Agreement, dated as of August 31, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**");

**WHEREAS**, in connection with the Credit Agreement, the parties entered into that certain Patent and Trademark Security Agreement, dated August 31, 2006 pursuant to which Assignor granted to Secured Party a security interest in certain of Assignor's assets including certain intellectual property owned by the Assignors, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Patent and Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Secured Party hereby terminates the Patent and Trademark Security Agreement (except for those obligations and liabilities that survive termination) and releases, without representation, recourse or warranty whatsoever, all of their security interest in the Intellectual Property Collateral, whether granted pursuant to the Credit Agreement or Patent and Trademark Security Agreement or any other agreement or document delivered in connection therewith, and the Secured Party hereby reassigns, without representation, recourse or warranty whatsoever, any and all such right, title and interest (if any) that the Secured Party may have in the Intellectual Property Collateral to the Assignor.

**IN WITNESS WHEREOF**, the Secured Party has executed this Release of Security Interest in Intellectual Property Collateral as of the date first above written.
