

WHEREAS, Assignor, on the Effective Date, owned the trademarks identified on Schedule A attached hereto (the "Trademarks"); and

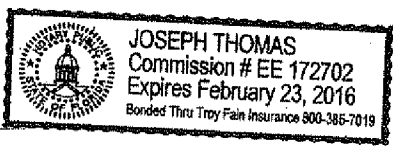
