CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment, with an Effective Date of January 26, 2015, is entered into by and between **JAMES E. PATRICK** ("ASSIGNOR"), a citizen of the United States of America, whose address is 8404 S. Wilmette Avenue, Suite B, Darien, Illinois 60561 and **SAGE PRODUCTS, LLC**, a Delaware limited liability company, whose address is 3909 Three Oaks Road, Cary, Illinois 60013 ("ASSIGNEE").

WHEREAS, prior to and on January 26, 2015, ASSIGNOR was the owner of the trademark LIFTAEM, including the federal registration for the mark, No. 4,004,807, issued on August 2, 2011, and all common law rights to the trademark, together with the goodwill of the business associated with the trademark (collectively all of ASSIGNOR'S rights to the trademark, including, but not limited to, the trademark registration, the common law rights and the goodwill of the business are referred to as the "LIFTAEM MARK");

WHEREAS, on January 26, 2015, ASSIGNOR entered into a trademark assignment agreement with ASSIGNEE (the "AGREEMENT"), whereby ASSIGNOR, assigned the LIFTAEM MARK to ASSIGNEE;

WHEREAS, ASSIGNOR and ASSIGNEE incorporate by reference all of the terms of the AGREEMENT as if full repeated herein and wish to confirm that the AGREEMENT transferred all rights associated with the LIFTAEM MARK, and all other rights described in the AGREEMENT, to ASSIGNEE as of the Effective Date of the AGREEMENT of January 26, 2015;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the ASSIGNOR does hereby confirm the assignment, transfer and sale of the ASSIGNOR'S entire right, title and interest in and to the LIFTAEM MARK, together with the goodwill of the business in connection with which the LIFTAEM MARK was used and which was symbolized by the mark as of January 26, 2015, and the ASSIGNEE confirms receipt of the assignment of the LIFTAEM MARK as of January 26, 2015.

IN WITNESS WHEREOF, the parties have caused this Confirmatory Trademark Assignment to be executed nunc pro tunc, with an Effective Date of January 26, 2015.
