**TRADEMARK RELEASE**

TRADEMARK RELEASE, effective as of this \_\_\_ day of November, 2012, given by DEUTSCHE BANK TRUST COMPANY AMERICAS, as Collateral Agent (“Agent”) with principal offices at 60 Wall Street, New York, NY 10005 to Sunrise Medical HHG Inc., a Delaware corporation (“Grantor”), with principal offices at 2382 Faraday Avenue, Suite 200, Carlsbad, CA 92008, as follows:

**W I T N E S S E T H**

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain trademarks, trademark registrations and trademark applications (the “Marks”) to secure the Obligations (as defined in that certain Security Agreement, dated as of May 13, 2004 and as amended and restated as of April 2, 2010 between the Agent and the Grantor (the “Security Agreement”)); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor the security interest in the Marks listed on the attached Schedule A (and only those Marks) granted to Agent by the Grantor pursuant to the Security Agreement, which security interest was duly recorded on June 9, 2004, at Reel 2983, Frame 0863 in the United States Patent and Trademark Office.
