TRADEMARK ASSIGNMENT

WHEREAS, Teachers-Teachers.com, Inc., a Maryland corporation (“**TT**”), was the original owner of the trademark identified on **Exhibit A** (the “**Trademark**”); and

WHEREAS, pursuant to Md. Code Ann., Corps. & Ass’ns § 3-515, Brett Spodak, the sole director of TT (“**Spodak**”), has become the trustee of TT’s assets for the purposes of liquidation and has been vested, in his capacity as trustee, with full title to all of TT’s assets, including the Trademark; and

WHEREAS, in connection with liquidating and winding up the affairs of TT, Spodak desires to assign to Teachers-Teachers.com, LLC, a Florida limited liability company (f/k/a Teachers-Teachers.com, Inc.) (the “**Company**”), Spodak’s entire worldwide right, title, and interest in and to the Trademark; and

WHEREAS, Spodak desires to execute this instrument of assignment in order to effectuate Spodak’s assignment of the Trademark to the Company.

NOW, THEREFORE, for good and valuable consideration, and the mutual promises, covenants, and undertakings herein set forth, the value, sufficiency, and receipt of which are hereby acknowledged, Spodak hereby agrees as follows:

Spodak hereby transfers and assigns to the Company all of his worldwide right, title, and interest in and to the Trademark, as well as the goodwill of the business associated with said Trademark, including, without limitation, all rights to police, monitor, and enforce said Trademark against any and all past, current, and/or future infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) and any and all further privileges in the United States and throughout the world to establish use, ownership, and/or registration of the Trademark.


Spodak hereby represents, warrants, and covenants that he has the full right to convey its above-described right, title, and interest in and to, and the goodwill associated with, the Trademark by this Assignment and that no other agreement has been or will be executed in conflict herewith.

Spodak agrees to perform all affirmative acts that may be reasonably necessary or desirable to the Company in order to record or perfect the above-described transfer of the Trademark, as well as reasonably cooperate with the Company in providing information required with respect to any recordations relating to the transfer of the Trademark. Without limiting the generality of the foregoing, Spodak agrees to sign such applications, assignment forms, and other documents as the Company reasonably requests from time to time to further confirm Company’s right, title, interest and ownership in the Trademark.

Spodak further authorizes the Commissioner of Patents and Trademarks of the United States, and the appropriate official in any other country, to issue any and all trademark registrations, amended registrations, and/or renewals that may be granted upon any application or petition for the Trademark to the Company and/or the Company’s successors and/or assigns.
