ASSIGNMENT OF TRADEMARK



Assignor hereby represents and warrants that it owns the Property and that Assignor is unaware of any existing or threatened claims of litigation in connection with the Property. Assignor further represents and warrants that it has not sold or transferred the Property to any third party and that Assignor has the full authority to enter into this Agreement.

Assignee acquires Assignor's entire interests and goodwill in and to the Property, including the right to receive monies in connection therewith (regardless of when vested or accrued), and Assignor does hereby assign and convey to Assignee all rights, title, interest, and goodwill if any in the Property, and, without limitation, the rights to obtain trademarks, service marks, and / or copyrights thereon throughout the entire universe. Hereafter, Assignee shall have the benefit of all trademarks, copyright, rights of publicity and any and all other rights of any kind or description relating to the Property which may be owned by Assignor; to enforce and protect the rights and privileges conveyed under the common law or statutory law of any country; to obtain, renew and extend the rights conferred hereunder; to prevent the infringement of the rights conferred hereunder; and also to litigate, collect and receive all damages arising from interference with or infringement of any and all such rights and to collect all damages, penalties and settlements and profits relating to or arising from any commercial use, interference or infringement of the rights granted Assignee hereunder.




