FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, DenTek Oral Care, Inc., a Tennessee corporation (the "Grantor"), with principal offices at 307 Excellence Way, Maryville, Tennessee 37801, hereby assigns and grants to FIFTH THIRD BANK, as Administrative Agent (the "Grantee") with principal offices at 222 S. Riverside Plaza, 30<sup>th</sup> Floor, Mail drop: GRVROK, Chicago, Illinois 60606, a security interest in all of the Grantor's right, title and interest in and to (i) the trademarks and trademark registrations (the "Marks") set forth on Schedule A attached hereto and all reissues, extensions or renewals thereof (ii) all Proceeds (as such term is defined in the Guaranty and Security Agreement referred to below) of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST (this "Grant"), is made to secure the satisfactory performance and payment of all the "Secured Obligations" of the Grantor, as such term is defined in the Amended and Restated Guaranty and Security Agreement by and among Grantor, the other grantors from time to time party thereto and the Grantee, dated as of May 8, 2014 (as the same may be amended, restated, modified and/or supplemented from time to time, the "Guaranty and Security Agreement").



In the event that any provisions of this Grant are deemed to conflict with the Guaranty and Security Agreement, the provisions of the Guaranty and Security Agreement shall govern.

THIS GRANT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK (WITHOUT GIVING EFFECT TO THE CONFLICT OF LAW PRINCIPLES THEREOF EXCEPT FOR SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW).


