INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment"), dated as of March 1, 2011, is made by ClarkWestern Building Systems Inc. ("CW"), in favor of ClarkDietrich Building Systems LLC, an Ohio limited liability company ("Joint Venture"), pursuant to that certain Contribution Agreement dated as of March 1, 2011 (the "Agreement"), by and among ClarkWestern Building Systems, Inc., Marubeni-Itochu Steel America Inc., a Delaware corporation, ClarkDietrich Building Systems LLC, Dietrich Industries, Inc. and Worthington Industries, Inc., an Ohio corporation.

Under the terms of the Agreement, CW has conveyed, transferred and assigned to Joint Venture, among other assets, certain intellectual property of CW, and has agreed to execute and deliver this IP Assignment, for potential recording with national, federal and state government authorities including, but not limited to, with respect to individual patents, registered trademarks and copyrights, applications for the foregoing and exclusive copyright licenses, the US Patent and Trademark Office and the US Copyright Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the CW agrees as follows:

1. Assignment. CW hereby conveys, transfers and assigns to Joint Venture all of CW's right, title and interest in and to the Business IP (as such term is defined in the Agreement), including all goodwill associated therewith.
2. Recordation. CW authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other national, federal and state government officials to record and register this IP Assignment upon request by Joint Venture.
3. Terms of the Agreement. The terms of the Agreement, including, but not limited to, the representations, warranties, covenants, agreements and indemnities relating to the Business IP are incorporated herein by this reference. In the event of any conflict or inconsistency between the terms of the Agreement and the terms of this IP Assignment, the terms of the Agreement shall govern.
4. Counterparts. This IP Assignment may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.


5. Governing Law. This IP Assignment shall be governed by and construed in accordance with the internal laws of the State of Ohio without giving effect to any choice or conflict of law provision or rule (whether of the State of Ohio or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of Ohio.

6. Further Assurances. Each of the parties hereto shall execute and deliver, at the reasonable request of the other party hereto, such additional documents, instruments, conveyances and assurances and take such further actions as such other party may reasonably request to carry out the provisions hereof and give effect to the transactions contemplated by this IP Assignment.
