RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, VIDARIS HOLDINGS, LLC (f/k/a Israel Berger & Associates, LLC), a Delaware limited liability company, IBA HOLDINGS, LLC, a Delaware limited liability company, ISRAEL BERGER & ASSOCIATES OF FLORIDA, LLC, a Delaware limited liability company, and ISRAEL BERGER & ASSOCIATES OF NEVADA, LLC, a Delaware limited liability company (collectively the "Grantors"), granted a security interest in and lien upon certain trademarks and related rights of Grantors to THE PRIVATEBANK AND TRUST COMPANY ("Secured Party") as set forth in that certain Trademark Security Agreement dated as of December 15, 2010, by Grantors in favor of Secured Party (as amended, restated, supplemented or otherwise modified from time to time, the "Agreement");

1. each trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark; and
2. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any trademark, or (b) injury to the goodwill associated with any trademark.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. Releases any and all liens, security interests, right, title and interest of Secured Party granted pursuant to the Agreement in the Trademark Collateral and in the trademarks of Grantors without recourse or representation or warranty, express or implied, of any kind;
2. Agrees that any power of attorney or similar rights granted by Grantors to Secured Party under the Agreement is terminated; and
3. Authorizes and requests that the USPTO note and record the existence of the release hereby given.
