ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS ("Assignment") is made and entered into as of the 21 day of August, 2013, by KVP INTERNATIONAL, INC., a California Corporation ("Assignor"), to and for the benefit of KV SUPPLY, LLC, a Delaware Limited Liability Company ("Assignee").

A. Assignment of Intangible Personal Property.

Pursuant to the terms of that certain Asset Purchase Agreement ("Purchase Agreement") dated August 21, 2013, by and between Assignor and Assignee, Assignor hereby assigns, conveys and transfers to Assignee to the fullest extent allowed by law, any and all of its right, title, interest, privileges, benefits and remedies in, to and under the following intangible personal property:

(iv) all pet product designs, concepts, templates, patterns and molds developed by Assignor during Assignor's conduct of the Business (as such term is defined in the Purchase Agreement);

(v) all content in the web sites known as www.seniorpetproducts.com www.wholelifepets.com including text, graphics, logos, code, programming, scripts, audio and all databases related to the web sites ("Websites"); and

(vi) all rights to sue or make any claims for any past, present or future misappropriation or unauthorized use of any of the foregoing rights and the right to receive income, royalties, damages or payments in connection with any of the foregoing arising after the date of this Assignment ("Claims").

B. Miscellaneous Terms.

(1) Assignor shall, upon request of Assignee, execute each further instruments or documents as Assignee may reasonably require to further effect the purposes hereof.

(2) This Assignment shall be binding upon and inure to the benefit of the successors and assigns of Assignor and Assignee.

(3) This Assignment shall be governed by and construed and interpreted in accordance with the laws of the State of California, without giving effect to the choice of law provisions of such state.
