## TRADEMARK ASSIGNMENT

3. No later than April 15, 2015, ASSIGNEE agrees to use its best efforts to conduct two large herd dairy evaluations of ASSIGNOR product OmniGen-AF® on a minimum of 4000 dairy cows at agreed upon ASSIGNEE customers.

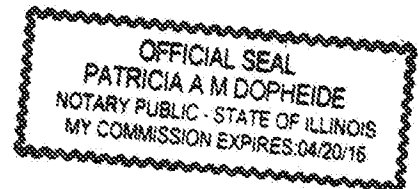
