This TRADEMARK RELEASE, granted on this \_\_\_\_ day of March, 2015, by Deutsche Bank Trust Company Americas, as Collateral Agent, with principal offices at 60 Wall Street, New York, New York 10005 (the "Grantee"), to Sunrise Medical HHG Inc., a California corporation, with principal offices at 7477 East Dry Creek Parkway, Longmont, CO 80503 (the "Grantor"), as follows:



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantee hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in and to the Marks, and more particularly, the security interest in (i) the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses symbolized by the Marks and (iv) all causes of action arising prior to or after the date of the earliest assignment and grant hereunder for infringement of any of the Marks or unfair competition regarding the same, and granted to the Grantee by the Grantor by the Security Agreement.
