**RELEASE OF SECURITY INTEREST**

This RELEASE OF SECURITY INTEREST is made as of March 13, 2015, by WELLS FARGO FOOTHILL, INC., formerly known as Foothill Capital Corporation ("Secured Party"), in favor of COCO'S RESTAURANTS, INC., a California corporation ("Grantor").

RECITALS

WHEREAS, Grantor granted a security interest in the trademarks described on Schedule A attached hereto ("Trademarks") to Secured Party pursuant to that certain Trademark Security Agreement dated as of July 10, 2002 ("Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on July 18, 2002, at Reel and Frame Number 2545/0138 and as amended by that certain Amendment Number One to Trademark Security Agreement dated as of April 25, 2008 ("Amendment") and recorded with the USPTO on May 16, 2008, at Reel and Frame Number 3783/0381 (the Security Agreement and the Amendment collectively referred to herein as the "Agreement"); and


WHEREAS, Grantor has no outstanding obligations to Secured Party under the terms of the Agreement and Secured Party agrees to release its security interest in the Trademarks.

Secured Party hereby reconveys to Grantor, without recourse or warranty, all Secured Party's right, title, claim and interest in and to the Trademarks, all proceeds thereof, all rights corresponding thereto including but not limited to all renewals, and extensions thereof, and the recordings and applications thereof.
