RELEASE OF SECURITY INTEREST IN TRADEMARK

WHEREAS, **Bacterin International, Inc.**, a Nevada corporation with offices located at 664 Cruiser Lane, Belgrade, Montana 59714 ("**Grantor**"), granted a security interest in and lien upon certain trademarks and related rights to **ROS Acquisition Offshore LP**, a Cayman Islands Exempted Limited Partnership ("**ROS**") with an address of Walker House, 87 Mary Street c/o Walkers Corporate Services Limited, George Town, Grand Cayman, Cayman Islands, as set forth in a certain Trademark Security Agreement, dated August 24, 2012, by and among Grantor and ROS (the "**Trademark Security Agreement**");

WHEREAS, an executed copy of the Trademark Security Agreement between Grantor and ROS was recorded in the United States Patent and Trademark Office on August 28, 2012 at Reel 4850, Frame 0600, and a corrective assignment to correct ROS's address was recorded in the United States Patent and Trademark Office on August 29, 2012 at Reel 4852, Frame 0788;

WHEREAS, Grantor has requested that ROS release and reassign their interests in the trademark "Quickscrew" and U.S. Trademark Registration No. 3,521,267 therefor; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, ROS hereby:

1. releases and reassigns to Grantor any and all liens, security interests, right, title and interest of ROS pursuant to the Trademark Security Agreement in the "Quickscrew" trademark, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to ROS with respect to the "Quickscrew" trademark pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
