ASSIGNMENT FOR SECURITY

(TRADEMARKS)

WHEREAS,

Savio Macchine Tessili S.p.A., a company incorporated in Italy as a *società per azioni*, with registered offices at via Udine 105, 33170 Pordenone (PN), fully-paid share capital of Euro 13,000,000.00, registered with the Companies Register of Pordenone, Tax Code and Registration no. with the Companies' Register 01291010930 [herein referred to as "Assignor"], owns the trademarks registrations of the United States, more particularly described on Schedule L-A annexed hereto as part hereof (the "Trademarks");

WHEREAS, the Assignor is obligated to Banca IMI S.p.A., acting as agent and lender ("BIMI") and Banca Popolare Friuladria S.p.A., Banca Popolare di Milano S.c. a .r.l., Credito Bergamasco S.p.A., Mediocredito S.p.A. and Mellorbanca S.p.A., acting as lenders (together with BIMI the "Lenders" or the "Assignees"), under the Euro 162,500,000 senior term and bridge facilities agreement dated November 8 2011, entered into, among others, the Assignor and the Assignees (as amended, modified or supplemented from time to time in accordance with its terms, the "Credit Agreement") and the Assignor and the Assignees have entered into a Security Agreement and Mortgage-Trademarks and Patents dated November 8 2011 (the "Agreement") in favor of the Assignees; and

WHEREAS, pursuant to the Agreement, Assignor has assigned to the Assignees, and granted to Assignees a security interest in, and mortgage on, all right, title and interest of the Assignor in and to the Trademarks, together with any reissue, continuation, continuation-in-part or extension thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof for the full term of the Trademarks (the "Collateral"), to secure the prompt payment, performance and observance of the Secured Claims (*Crediti Garantiti*), as defined in the Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor does hereby further assign unto Assignees and grant to Assignees a security interest in, and mortgage on, the Collateral to secure the prompt payment, performance and observance of the Secured Claims (*Crediti Garantiti*), as defined in the Agreement.


