
1. The name and type of entity of the converted entity and the jurisdiction of its governing statute is Daniel & Yeager, LLC, an Alabama limited liability company.
2. The former name of the converting entity is Daniel & Yeager, Inc.
3. Daniel & Yeager, Inc. is hereby converted into Daniel & Yeager, LLC.
4. The Articles of Incorporation of the converting entity were originally filed with the Alabama Secretary of State on October 25, 1989. *Madison County Probate*
5. The nature of the business and the purposes for which the converting entity is formed shall be as follows:
 - a) To provide support and personnel services and locum tenens services in the medical field, and to provide and perform all related services thereto;
 - b) To do all things necessary, desirable, or expedient in the operation, management, and conduct of the aforesaid business; and
 - c) To transact all lawful business for which limited liability companies may be formed under the Alabama Business and Nonprofit Entity Code.
6. This Statement of Conversion shall be effective as of 10:45 PM Central Standard Time on the 31st day of December 2014.
7. This Statement of Conversion has been approved in accordance with Section 10A-1-8.01 of the Alabama Business and Nonprofit Entity Code.
