## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, effective as of the 17 day of March 2015, by and between Barry T. Chouinard, Inc., a corporation organized under the laws of the State of Vermont (hereinafter referred to as the "ASSIGNOR") and Gildan Activewear SRL, a Barbados Sociedad de Responsabilidad Limitada, having an address of Newton, Christ Church BB17047, Barbados (hereinafter referred to as "ASSIGNEE") (collectively, the "Parties"); and

WHEREAS, ASSIGNOR is the exclusive and record owner of the entire right, title, and interest in and to the trademarks and the corresponding U.S. registrations identified in Exhibit A attached hereto, (the "Trademarks"), together with the goodwill established by use of the Trademarks;

WHEREAS, ASSIGNEE is desirous of acquiring the Trademarks;

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby assign, transfer, and sell unto said ASSIGNEE the entire right, title, and interest in and to the Trademarks and the associated usage and goodwill, including all rights of action against third parties for past, present and future infringement or other unauthorized use of the Trademarks, the same to be held and enjoyed by said ASSIGNEE as fully and entirely as the same would have been held by ASSIGNOR had this transfer, assignment, and sale not been made.

ASSIGNOR hereby warrants and covenants that (i) it has the full power and authority to convey the rights, title, and interest herein assigned, transferred, and sold to ASSIGNEE; (ii) there are no judgments, decrees, orders, liens, encumbrances, restrictions, security interests, or agreements against or binding upon the Trademarks or ASSIGNOR which prohibits or restrict the use of the Trademarks; (iii) it has not executed and will not execute any agreement in conflict herewith; and (iv) that it will execute any and all other instruments which may be necessary to perfect and evidence ASSIGNEE's ownership of the property and rights herein conveyed.

The Parties agree that this Assignment constitutes the entire agreement between ASSIGNOR and ASSIGNEE with respect to the subject matter hereof. The Parties also agree

that no modification or waiver or any amendment to any provision of this Assignment shall be binding upon either party unless it is made in writing and signed by both Parties.

IN WITNESS WHEREOF, the Parties, intending to be legally bound, have caused this Assignment to be executed by its duly authorized officers.
