ASSIGNMENT OF TRADEMARK *NUNC PRO TUNC*

Pozo, the full and exclusive right, title and interest in and to the mark "BRO", together with the goodwill associated therewith and including U.S. Trademark Registration No. 2,725,046 therefor and any other registrations and/or pending applications therefor in this or a foreign country, for its own use and benefit in the territory of the United States of America and extending to all foreign countries, as fully and entirely as the same would have been held and enjoyed by Muscletank Corporation had this assignment not been made;

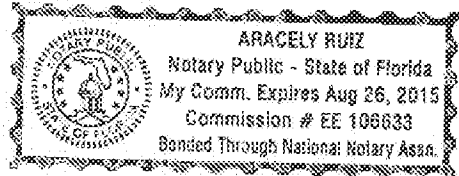
