ARTICLES OF AMENDMENT  
 TO THE  
 ARTICLES OF INCORPORATION  
 OF  
 INSUL-8 CORPORATION

Pursuant to the provisions of Section 21-20,116 of the Business Corporation Act of Nebraska, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: Insul-8 Corporation.

SECOND: The following Amendment of the Articles of Incorporation was adopted by the Unanimous Written Consent of the Board of Directors on November 21, 2005, and by the sole shareholder of the Corporation on November 21, 2005, in the manner prescribed by the Business Corporation Act of Nebraska.

Article I of the Articles of Incorporation of Insul-8 Corporation is amended to read as follows:

ARTICLE I


The name of the corporation is: Conductix, Inc.
