THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 20, 2015, by GOLUB CAPITAL LLC, as administrative agent ("Grantee").

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademarks and other Trademark Collateral and reassign the same to the Grantor.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
