TERMINATION AND RELEASE OF LIEN IN TRADEMARKS

THIS TERMINATION AND RELEASE OF LIEN IN TRADEMARKS (this "Termination"), is dated as of March [20], 2015, and made by WEBSTER BANK, NATIONAL ASSOCIATION, having a business address at [80 Elm Street, New Haven, Connecticut 06510] ("Grantee") to MDEVERYWHERE, INC., a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of April 21, 2010, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by Grantor to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 23, 2010, at Reel 004191 and Frame 0229; and

WHEREAS, Grantee now desires to terminate and release its security interest in the Trademark Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
