**CERTIFICATE OF FORMATION
OF
MERCHANTS METALS LLC**

The undersigned, being over the age of 18 years and acting as sole organizer of a limited liability company under the Delaware Limited Liability Company Act (the "Act"), does hereby adopt the following Certificate of Formation for Merchants Metals LLC (the "Company").

ARTICLE ONE

The name of the limited liability company is Merchants Metals LLC.

ARTICLE TWO

The address of the initial registered office of the Company in the State of Delaware is 2711 Centerville Road, Suite 400, Wilmington, Delaware, 19808, and the name of its registered agent for service of process required to be maintained by Section 18-104 of the Act in the state is Corporation Service Company.
