2. The Certificate of Incorporation of the Corporation is hereby amended by striking out Article numbered **First** thereof and by substituting in lieu of said Article the following new Article:

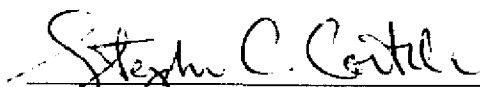
**"First:** The name of this Corporation is Vencore Labs, Inc. ("Corporation")."
