**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks (this "Release") is made this <sup>24</sup> day of March 2015 (the "Effective Date") by SPRING CAPITAL PARTNERS, L.P., a Delaware limited partnership having a business address at 2330 West Joppa Road, Lutherville, Maryland 21093 ("Secured Party"), in favor of Rock-It Cargo, USA, Inc., a Delaware corporation having a business address at 1800 Byberry Road, Suite 909, Huntingdon Valley, Pennsylvania 19006 ("Grantor") and ROCK-IT CARGO USA LLC, a Delaware limited liability company having a business address at 1800 Byberry Road, Suite 810, Huntingdon Valley, Pennsylvania 19006.

WHEREAS Secured Party and Grantor entered into that certain Proprietary Rights Security Agreement, dated as of September 30, 2004 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor granted to Secured Party a security interest in all of Grantor's right, title and interest in, to and under its Proprietary Rights (as that term is defined in that certain Investment Agreement dated as of September 30, 2004, by and among Secured Party and Grantor (the "Investment Agreement")), including without limitation the trademarks identified in EXHIBIT A hereto (the "Trademarks"), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions, and continuations-in-part thereof;

WHEREAS the Security Agreement was recorded with the United States Patent and Trademark Office against the Trademarks at Reel/Frame 2951/0446 on October 1, 2004;

WHEREAS Grantor has fully paid its obligations under the Investment Agreement and all other agreements between Grantor and Secured Party, and Secured Party desires to release and discharge its security interest in the Proprietary Rights, including without limitation the Trademarks;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, and intending to be legally bound hereby, Secured Party hereby releases and remits to Grantor any and all right, title and interest in, to and under the Proprietary Rights, including without limitation the Trademarks, granted pursuant to the Security Agreement. This Release hereby confirms the termination and release of any and all previous security interests granted to Secured Party by Grantor. Secured Party specifically acknowledges that Secured Party does not own any rights to or have any ownership interest in the Proprietary Rights, including without limitation the Trademarks, and hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.
