TO ARTICLES OF INCORPORATION OF

Pursuant to Section 14-2-1006 of the Georgia Business Corporation Code (O.C.G.A. § 14-2-101 *et seq.*), ATLANTA ARMY & NAVY STORE, INC., a Georgia corporation, hereby submits the following Articles of Amendment:


