INTELLECTUAL PROPERTY ASSIGNMENT

WHEREAS, the Assignee desires to acquire all of the Assignors' rights, title, and interests in and to the Shadow Warrior Assets;

NOW, THEREFORE, in consideration of the covenants and premises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:


1. ASSIGNMENT OF ASSETS.

This Assignment shall be governed by the laws of the state of Texas, without regard to conflicts of law principals thereof. In the event that litigation results from or arises out of this Assignment or the performance thereof, the Parties agree to reimburse the prevailing Party's reasonable attorneys' fees, court costs, and all other expenses, whether or not taxable by the court as costs, in addition to any other relief to which the prevailing Party may be entitled.

4. COUNTERPARTS/ELECTRONIC SIGNATURES.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument. For purposes of this Assignment, use of a facsimile, e-mail, or other electronic medium shall have the same force and effect as an original signature.

5. WARRANTIES AND REPRESENTATIONS.

Assignors, jointly and severally, warrant and represent that (i) there are no claims, liabilities, liens, UCC filings, or other encumbrances of any kind, threatened, filed or asserted against any of the Shadow Warrior Assets that would prevent any of the

transfers, assignments or licenses contained in this Assignment, (ii) they are the sole and exclusive owners of the entire right, title, and interests in and to the Shadow Warrior Assets and any other rights transferred, assigned or licensed under this Assignment, and (iii) they have the full power and authority to enter into this Assignment and to make the transfers, assignments, and licenses provided herein.
