WHEREAS, this Assignment is being made in furtherance of an Agreement of even date herewith between Assignor and Assignee with regard to the purchase of certain assets pertaining to the pharmaceutical product Vecamyl by Assignee and the subsequent use of the Trademark by Assignee or its assignee or transferee on, and with respect to, the product Vecamyl.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the Assignor, for itself and its successors and assigns, does hereby transfer, assign and set over unto the Assignee, its successors, transferees and assigns, all of Assignor's present and future right, title and interest in and to the Trademark, free and clear of any liens or other third party rights or interests therein or with respect thereto, the goodwill of the business associated with the Trademark, all common law rights related thereto, all rights to seek and collect damages and other relief for past and future infringements and all proceeds thereof, and all rights and proceeds associated therewith.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States to record the rights to the Trademark as the property of the Assignee.

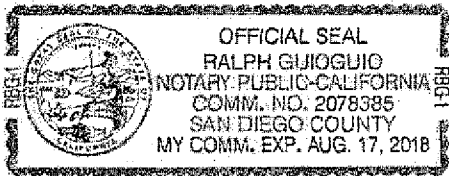
